





LOAD: UN 1263, Paint related material, Special provision 640D.

ENAMO GRIP

Classification: **3, II, F1**



DESCRIPTION:

Liquid. Solvent-like odour. Insoluble in water.
Volatile. Flashpoint: 2 °C.

NATURE OF DANGER:

Highly flammable. May be ignited by sparks. Gas/vapour spreads at floor level: ignition hazard. Gas/vapour explosive with air within explosion limits. Irritating to eyes. Vapours may cause drowsiness and dizziness. Water pollutant (surface water). On burning: release of toxic and Corrosive gases/vapours (nitrous vapours, carbon monoxide/carbondioxide).

PERSONAL PROTECTION:

Warning vest, suitable gloves, suitable eye protection, suitable foot protection, basic body protection, handlamp, eye-wash bottle with clean water.

GENERAL ACTIONS by the driver:

Stop the engine. No naked lights. No smoking.
Mark roads and warn other road users or passers-by.
Inform the public about the hazard and give advice to keep upwind.
Notify police and fire brigade as soon as possible: TEL 112(*).

ADDITIONAL AND/OR SPECIAL ACTIONS by the driver:

Plug the leak, cut off the supply, provided that this can be achieved without personal risk. Dam up the spill, take up the spill into absorbent material e.g. sand, earth.

FIRE: Information for the driver in case of fire:

Drivers shall not attempt to deal with any fire involving the load.

FIRST AID:

After inhalation : remove the victim into fresh air.
After eye contact : wash immediately with lots of water.
After skin contact: wash immediately with lots of water and soap.
After ingestion : rinse mouth, give lots of water to drink; consult a doctor

Additional information provided by manufacturer or sender:

Information for the fire brigade:

FIRE EXTINGUISHING MEDIA: water spray, polyvalent foam, BC powder or carbon dioxide. If exposed to fire cool the closed containers by. Spraying with water. Dilute toxic gases with water spray. Take account of environmentally hazardous firefighting water.
